- Get promotion to division 2 and division 4 for our first two teams
- Conduct an open tournament during the year
- Begin a major refurbishment to modernize the bar and club house
- Improve the surrounds of the two greens
- Play Saturday pennant bowls on the natural grass green as much as possible
- Increase our Bowls for the blind, Bowls for the disabled and Jack Attack for Kids programs
- Increase sponsorship by local business by \$4,000 per annum

#### So how did we go?

- Premierships in the day and night for our first team
- Promotion of the Seconds to Div 4 and firsts to Div 2
- The 3rds just missing on finals in their second year. They and the fourths are in the same grade as our second side was just three seasons ago
- Fielding of a 4th team for the first time in many years was challenging and stressful for the selectors and players however on paper we had the players. We did field 4 tams on nine occasions and the fourth team made a positive cash flow contribution to the club
- We fielded three competitive pennant teams on a Tuesday night introducing predominantly younger "still working" bowlers to the game. For the first time in our history we will field a division one team this team in the Tuesday night pennant competition.
- An increase in our membership numbers especially female members
- Barefoot Bowls was highly successful bringing potential new bowlers to the club also raising significant funds
- The barefoot program has also provided a connection with local businesses Philip Morris, Home Timber and Hardware, Stop'n Paws dog grooming, Hardware Supply Braeside, Taskforce, Inkerman Panels, Holmesglen Tafe, Melbourne United Basketball Club, The Renegades Cricket Club, APT Travel, St Catherine's and Southmoor Primary Schools
- Launched the Bayside Pro Am competition with three other Bayside clubs
- We ran our first Major Tournament for some time which was a huge success
- Professional coaching was provided by Robbie Briglia
- Our winter and Monday Triples programs were once again fantastically run and were well attended by visiting clubs
- Thanks to our sponsorships from Tara Ferrier at Hodges Real Estate, O'Brien Glass and Platinum Physio we reached our sponsorship targets

Our club tournaments were wonderfully supported and I just want to say congratulations to all our winners and organisers of these events.

Thank you to all our wonderful helpers in the kitchen and behind the bar, our sub committees and all our fabulous office bearers who work tirelessly to run the club efficiently.

We are in consultation with the St Kilda Footy Club and we are positive and excited by their return. We will continue our strong relationship with the City of Kingston to improve our facilities and continue to improve our great club.

#### TREASURERS REPORT

#### FINANCIAL PERIOD ENDED 30 JUNE 2016

I have pleasure in sumitting the 61st Annual Report for the Club. There was a net increase in available funds of \$6,660, but after amortization of the synthetic green (\$10,000) our unallocated funds had a net decrease of \$3,340. This has resulted from an increase in income of \$8,987 and a decrease in expenditure of \$1,835 compared with the previous year. There have been many factors influencing the result, some of which are:-

 the continued influx of new members from the Omega Cricket Club, which is most welcomed.

the continued support of social membership from the Italian Social Club, which is also most welcomed.

3. the increase in jncome was due the fact that we now have more members contributing to the subsciptions, green fees and bar.

4. the decrease in expenditure is due to a number of factors, namely the cost of maintaining our gardens & lawns almost halved this year due to a concious effort to tidy up the club surrounds ourselves rather than paying outsiders to do it. Despite the moaning and groaning a number of very good members attended quite a few working bees to help achieve this. We all remember how expensive our West Green became last year, due to a number of one off costs. The cost of running the green this year has dropped dramatically as expected, however the savings here were offset by an increase in our insurance costs and also the fact that we have 2 years lease payments included in this 15 month period.

5. the most significant reason we haven't had a great 15 months financially, is that we have included 2 June quarters in this report. The June quarters are by far our slowest financial quarters & to have 2 included & not show a significant drop in perfermance is very heartening.

6. interest income totalled \$4,049 all of which was rolled over & re-invested.

The asset register I am informed has been kept more for insurance purposes than for accounting purposes, so please don't simply accept the values attributed to each asset, they might be slightly overstated.

The work of committees, card players, trophy donors, trading table donors, caterers, gardeners, cleaners, bar attendants, etc, etc, not only generates income, but also reduces costs. To those members who so generously volunteer their time to carry out these tasks, we are very grateful.
